

1. General provisions

- 1.1 The subject of the Regulations is to define the terms of access and use of the Spaner application (hereinafter "Spaner" or "Tool") by Users who have a Personal Spaner Account on the <http://www.arcelormittal-construction.com.pl/spaner/logowanie.php> website, managed by the Administrator.
- 1.2 The User is obliged, prior to using the Tool, to carefully read the Regulations, to accept them without reservation and to undertake to comply with them.

2. Definitions

- 2.1. Administrator of personal data: ArcelorMittal Construction Polska Spółka z ograniczoną odpowiedzialnością with its registered office in Świętochłowice, 1 Metalowców Street, 41 - 600 Świętochłowice, entered into the Register of Entrepreneurs of the National Court Register at the Katowice-Wschód District Court in Katowice, VIII Economic Division of the National Court Register, KRS number 0000050192, REGON number 290571918, NIP number 664-10-03-716.
- 2.2. Regulations: means the document constituting the general terms of use for Spaner.
- 2.3. Personal Account: means the User's personal space, created and managed using personal identifiers (that is, the login and password selected by the User) at the <http://www.arcelormittal-construction.com.pl/spaner/logowanie.php> website, enabling access to the Tool.
- 2.4. Tool: means the Spaner application being the subject of the Regulations, created and designed by NP System, the owner of it and all intellectual property rights in this respect, and made available to Users via the <http://www.arcelormittal-construction.com.pl/spaner/logowanie.php> website.
- 2.5. User: an Internet user who obtained the possibility of using the Tool after connecting to the <http://www.arcelormittal-construction.com.pl/spaner/logowanie.php> website and approving the Regulations.

3. Using the tool

- 3.1. As part of the obtained rights to use the Tool, the Administrator makes it available to the Users who undertake to use the Tool in a manner consistent with the intended use and within the scope strictly defined in the Regulations, via the <http://www.arcelormittal-construction.com.pl/spaner/logowanie.php> website.
- 3.2. The tool is made available to the User free of charge, for personal use.
- 3.3. Having executed a design, the User does not acquire copyrights to the program, service, graphics, logo, design, software, technology, brand, invention, materials or anything related to the Tool, except for the copyright resulting exclusively from the model created by the User, where the model is a manifestation of the creative activity of an individual nature, in accordance with the provisions of the Act of 4 February 1994 on Copyright.
- 3.4. Spaner enables dimensioning trapezoidal sheets in accordance with the requirements of PN-EN 1993-1-3 and enables setting loads that are evenly distributed as well as variable loads. Basing on the fire classification guidelines and the reduction of stress specified therein, it is also possible to interpret the results.
- 3.5. The tool enables modeling systems with a maximum of five spans with a varied span of each, as well as calculating metal supports. The results of dimensioning are generated in pdf files with full static analysis and the verification of Ultimate Limit States and Limit States of Use.

3.6. The User has the possibility to save his (her) model (s) developed online with the help of the Tool provided that he has a Personal Account, after the registration procedure described in Paragraph 6 below.

3.7. After saving, the User can open the design at any time, supplement it, change it or use all other functionalities available within the Tool, connecting to his Personal Account at <http://www.arcelormittal-construction.com.pl/spaner/logowanie.php>.

3.8. The use of all of the functions of the Tool is possible provided that the User's IT system meets the following technical requirements:

- 1) the following browsers: Internet Explorer version 10.0 or newer with ActiveX, JavaScript, Adobe Flash Player and Cookies enabled or Mozilla Firefox version 11.0 or newer with Java applets, JavaScript, Adobe Flash Player and Cookies enabled,
- 2) minimum screen resolution: 1280 x 720 pixels.
- 3) a mouse and a keyboard to take full advantage of the Tool's feature.

3.9. In addition to the requirements set out in 3.8 above, the tool does not require any elements to be downloaded before its use.

4. Registration procedure to use the Tool

4.1. In order to gain access to the Tool and use the functionalities it offers, the User should register at the <http://www.arcelormittal-construction.com.pl/spaner/logowanie.php> website,

4.2. In order to log in, the User should first:

- 1) have a pre-existing Personal Account registered at the <http://www.arcelormittal-construction.com.pl/spaner/logowanie.php> website,
- 2) create a Personal Account, giving your name, position, company name, address, country, phone number, email address, password for the account at <http://www.arcelormittal-construction.com.pl/spaner/logowanie.php> website.

4.3. Registration is free-of-charge.

4.4. The User is informed that in order to be able to save and then work with the previously developed models, he must have and connect via his Personal Account.

5. Personal data

5.1. Providing personal data, the Participant agrees to their processing by the Administrator for the purposes necessary to manage the Tool.

5.2. The Administrator has secure IT resources enabling easier management of registration procedures for the website related to the Tool and Personal Accounts, and establishes computerized files with the personal data of the Users registered via the Tool.

5.3. The Users' personal data is protected and processed in accordance with the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (hereinafter referred to as the "GDPR"), and the national regulations on the protection of personal data.

5.4. The Administrator has not appointed a data protection officer. In all matters relating to the processing of personal data by the Company and the use of rights related to the processing of data, you can contact via email: rodo.amds@arcelormittal.com or in writing to the Administrator's address, additionally marked "Personal data".

- 5.5. The User has the right to inspect their data, to correct it and demand to cease the use of it or to remove or transfer it. Providing personal data by the User is voluntary, but consent to the processing of it is necessary to complete the registration process. Withdrawal of the User's consent does not affect the lawfulness of the processing which was made on the basis of the consent before its withdrawal.
- 5.6. The User has the right to object to the processing of data for direct marketing purposes.
- 5.7. In any case regarding the protection of personal data, the User has the right to file a complaint to the competent authority for the protection of personal data.
- 5.8. The User is responsible for protecting his personal identification data used to access his Personal Account and the Tool, as well as for the activities and measures undertaken through his Personal Account. Therefore, he should take all necessary measures to ensure adequate protection. It is recommended to use secure (strong) passwords that are a combination of uppercase and lowercase letters as well as numbers and symbols). The Administrator is not responsible for losses and damages resulting from non-compliance with the above requirements.
- 5.9. The User's personal data shall be kept for 5 years. After the expiry of the said period, the data is deleted or anonymized.
- 5.10. Personal data can be provided to recipients and other legal entities to the extent that they are necessary for them to perform the tasks ordered by the Administrator or if required by the law in force. The collected personal data is not transferred to recipients located in countries outside the European Economic Area (European Union countries and Iceland, Liechtenstein and Norway).
- 5.11. The personal data processed shall not be subject to automated decision-making processes by the Administrator, including profiling.

6. Responsibility

- 6.1. The Administrator undertakes to implement all measures necessary to ensure permanent access to the Tool at the <http://www.arcelormittal-construction.com.pl/spaner/logowanie.php> website. However, due to technical reasons, there can be interruptions in access to the Tool for the shortest possible period.
- 6.2. The Administrator does not bear any responsibility in case of any damage that could result from the lack of access to the Tool or from any problems related to the connection to the Personal Account.
- 6.3. The Administrator is not responsible for the models created by the User using the Tool. The Administrator shall not be liable in connection with claims, disputes or claims for damages formulated by third parties or another Users in connection with the models, Personal Account or any other elements related to the Tool.

7. Final Provisions

- 7.1. The Administrator reserves the right to change the Regulations at any time in the event of changes to the law or to improve the operation of the Tool, as well as to improve the protection of users' rights and to prevent abuse. The User can submit a statement of acceptance or non-acceptance of the new Regulations through the mechanism made available by the Administrator or send his statement to the Administrator's address. Upon receipt of a declaration of the non-acceptance of amendments to the Regulations, the Administrator shall delete the Account held by the End Customer and inform him of the fact.

7.2. The Regulations shall take effect as from 25.05.2018.
